1. Introduction by Dave Jackson

We're all very excited to present this public improvement project to you... and to give you an opportunity to help us do a little more for you where the new sidewalk will meet your existing driveways. And we'll do all of this construction... at no cost to you! So keeping that in mind... lets welcome Project Manager Chris Solis up here to give us an overview of the project. Chris?"

2. Project Overview by Christopher Solis

The purpose of the project is to provide safe connecting routes towards the local schools especially among students, increasing & improving connectivity to local businesses, parks and to slow down traffic in the El Rio Community. The Project consists of constructing pedestrian improvements on Walnut Drive, Cortez Street and Stroube Street in the El Rio area and were selected based on public outreach survey.

The proposed Improvements include the construction of concrete sidewalks, accessible ramps, crosswalks with rectangular rapid flashing beacons, traffic calming intersection improvements, community mailbox replacements, drainage improvements, and stormwater treatment Best Management Practices.

The County has adequate Right of Way to construct the proposed improvements which will maintain one residential travel lane in each direction, a parking lane on each side of the street, curb & gutter, sidewalk, and space for drainage improvements.

The improvements are on existing residential streets that have existing features such as driveways, fences, walls, and mailboxes. Those existing encroachments will have to be removed from the right of way. Where possible, some exceptions or accommodation will be made by temporarily relocation and replacement or modified so the new improvements conform to existing.

The County will contact you requesting permission to be on your property for the purpose of:

- matching the grade such as matching the elevation of your driveway to the grade of the top of the new sidewalk
- matching walkway, or steps by reconstructing to meet new walk
- removal of trees, shrubs or landscaping within Right of Way
- relocating and or replacing mailboxes
- removing & relocating fences and
- other features in order to build the new improvements.

This work will be done at no cost to you.

This project will serve as a spine for future projects to branch off from and provide connectivity in the El Rio Community to promote active modes of transportation, advance efforts to achieve

greenhouse gas reduction goals, enhance public health and to benefit disadvantaged communities.

3. Active Transportation Plan Public Engagement by Darren Arrieta

The County of Ventura, Roads & Transportation Department is developing an Active Transportation Plan for the entire Unincorporated Ventura County. The plan will be a roadmap for implementing pedestrian and bicycle infrastructure projects.

Similar to how the County asked the community of El Rio to provide input on where they would like improvements and what type of improvements, they would like in the El Rio Community. The County is now asking all residents to provide input on where in the Unincorporated County you would like pedestrian and bicycle facilities and what type of facilities you would like. Just like this sidewalk project will connect El Rio to the neighboring schools, places of worship, The Collection at River Park, and local medical facilities and stores. The County is trying to figure out our next projects to apply for grants and/or construct to connect other communities in the County to their neighborhood destinations.

The Active Transportation Plan is highlighted in the Ventura County General Plan as a need to help achieve some of the Countywide goals of improving public health and reducing environmental impacts by reducing vehicle miles traveled and greenhouse gas emissions.

We know that the residents of El Rio are passionate about their community and the County, and we welcome all input and engagement for the County of Ventura Active Transportation Plan.
